United Kingdom's National Security Threat

Introduction

The main threats to national security are terrorism, espionage, cyber threats and the proliferation of weapons of mass destruction, many of which impact on the UK's national infrastructure.

National infrastructure sectors represent core strategic interests for foreign intelligence services, whose targeting against the sectors is likely to include espionage for economic, political, military or commercial gain.

While the threat from terrorism to the UK as a whole is high, and historically both international and Northern Ireland terrorist groups have targeted UK infrastructure, the current terrorist threat to the national infrastructure can be characterised as generally limited and often aspirational.

The exception is transport which continues to face enduringly high levels of threat from international terrorism. In addition, the emergency services and defence sectors, specifically police and military personnel, also face a high level of threat from both international terrorism and dissident republican groups in Northern Ireland, for whom they are a priority target for attack.

Generally higher levels of effective and visible protective security at national infrastructure sites are likely to act as a deterrent to terrorists, who increasingly favour 'soft' targets which allow them to achieve their aims with greater chance of success. Nevertheless, with the continual diversification of the threat, the ambition and capability of terrorist groups to target UK infrastructure is likely to continue to evolve. <https://www.cpni.gov.uk/national-security-threats>

United Kingdom's Threat Definitions

International terrorism



International terrorism from groups such as the Islamic State in Iraq and the Levant (ISIL) and Al Qaida present a threat from many others. They hold territory in places without functioning governments, making it easier for them to train recruits and plan complex, sophisticated attacks. Drawing on extreme interpretations of Islam to justify their actions, these groups often have the desire and capability to direct terrorist attacks against the West, and to inspire those already living there to carry out attacks of their own.

Northern Ireland-related terrorism

Northern Ireland-related terrorism continues to pose a serious threat to British interests. Although the Provisional Irish Republican Army (PIRA) has ceased its terrorist campaign and is now committed to the political process, some dissident republican groups continue to mount terrorist attacks, primarily against the security forces.

Domestic extremism

Domestic extremism mainly refers to individuals or groups that carry out criminal acts in pursuit of a larger agenda, such as "right-wing extremists". They may seek to change legislation or influence domestic policy and try to achieve this outside of the normal democratic process. <https://www.mi5.gov.uk/counter-terrorism>

Cyber

"Cyberspace" is the term used to describe the electronic medium of digital networks used to store, modify and communicate information. It includes the Internet but also other information systems that support businesses, infrastructure and services.



Cyberspace lies at the heart of modern society; it impacts our personal lives, our businesses and our essential services. A secure online environment is essential to HM Government, which is providing an ever-increasing number of online services to UK citizens and businesses as part of a major digital services transformation programme. The ability to conduct online transactions securely is central to the delivery of public and commercial services and communications. However, some individuals and groups use cyberspace for malicious purposes. We call these people 'hostile actors' and they exploit cyberspace to conduct espionage operations or launch damaging computer network attacks.

Cyber security affects both the public and the private sector and spans a broad range of issues related to national security, whether through terrorism, crime or state and industrial espionage. <https://www.cpni.gov.uk/cyber>

Espionage

The potential impact of successful State-sponsored espionage against the UK is both wide reaching and significant. The threat of espionage (spying) did not end with the collapse of Soviet communism in the early 1990s. Espionage against UK interests still continues and is potentially very damaging. A number of foreign intelligence services (FIS) seek to gather intelligence on a broad range of subjects, including foreign policy, defence, financial, technological, industrial and commercial interests. <https://www.cpni.gov.uk/espionage>

What the threat levels mean

Threat levels are designed to give a broad indication of the likelihood of a terrorist attack.

LOW

- Means an attack is unlikely

MODERATE

- Means an attack is possible, but not likely

SUBSTANTIAL

- Means an attack is likely

SEVERE

- Means an attack is highly likely

CRITICAL

- Means an attack is highly likely in the near future

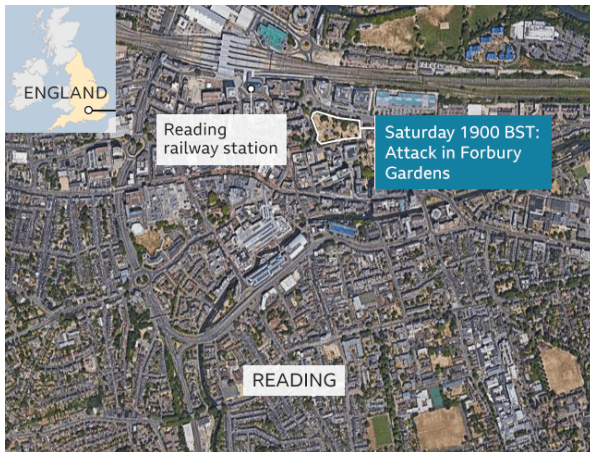

Terrorist attack kills three and wounds three others in Reading



Authorities arrested a Libyan national who killed three people and wounded three others in a stabbing attack in Forbury Gardens, Reading. Police declared the stabbings a terrorist attack after initially saying the incident was not being treated as terror related. The last terrorist attack in the UK took place in February 2020, when an individual wore a fake suicide vest and stabbed two people in Streatham.

Police clash with crowd at illegal party in London

Police clashed with a crowd as they attempted to break up an illegal party in Notting Hill. Metropolitan Police said that individuals threw objects at police officers. This was the second consecutive night that police have reported being attacked while dispersing illegal events around London. In a similar incident on 25 June, Scotland Yard reported that 22 officers were injured after dispersing an illegal party in Brixton.

Knife wielding assailant wounds six in Glasgow

An attacker armed with a knife wounded six people, including a police officer, in Glasgow. Police shot dead the suspected assailant. The stabbing took place at the Park Inn hotel, which houses asylum seekers. Authorities said the incident was not being treated as terror-related and that there was no more danger to the public.

NCA and police smash thousands of criminal networks in Operation Venetic

Entire organised crime groups were dismantled during Operation Venetic with 746 arrests, and £54m criminal cash, 77 firearms and over two tonnes of drugs seized so far. EncroChat was one of the largest providers of encrypted communications and offered a secure mobile phone instant messaging service, but an international law enforcement team cracked the company's encryption.

746 suspects arrested

By the National Crime Agency, Regional Organised Crime Units and UK police forces, following the infiltration of encrypted communication platform EncroChat.



There were 60,000 users worldwide and around 10,000 users in the UK – the sole use was for coordinating and planning the distribution of illicit commodities, money laundering and plotting to kill rival criminals. Operation Venetic is the biggest and most significant operation of

its kind in the UK.

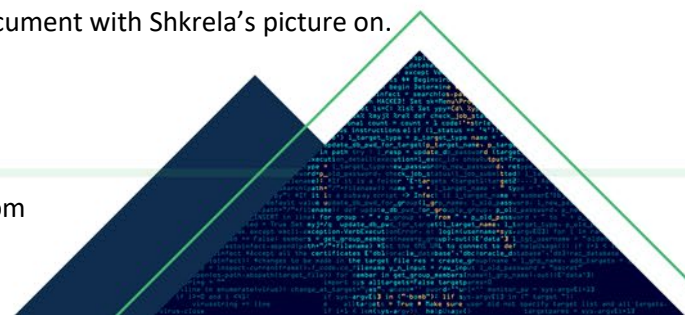

London drug dealer jailed for cocaine and money laundering



An Albanian national been sentenced to 4 years in jail after admitting cocaine supply and money laundering yesterday at Inner London Crown Court. Amir Shkreka, 27, was the subject of an investigation by the Organised Crime Partnership (OCP) – the joint National Crime Agency and Metropolitan Police Service fight against serious organised crime. Shkreka, of Goldhawk Road, London, W12 was under surveillance by OCP officers when he was seen getting into the passenger seat of a car on Benbow Road, with two bags.

Officers stopped the car as it drove onto the A40 and arrested Shkreka. They recovered three kilos of cocaine from the bag. A search of his premises led to the further seizure of £181,000 in cash, and a false ID document with Shkreka’s picture on.



West Belfast properties frozen as part of proceeds of crime investigation

National Crime Agency officers working as part of the Paramilitary Crime Task Force executed a search of a residential property in the West Belfast area as part of an operation targeting the proceeds of crime. Following the search, during which mobile devices, documentation and a quantity of cash was seized for further investigation, a Property Freezing Order was served, restraining three properties all located in the West Belfast area.

Isle of Wight man charged over Newhaven £10m cocaine seizure



A man from the Isle of Wight has been charged as part of a National Crime Agency investigation into the seizure of cocaine worth £10 million at Newhaven port in East Sussex in November 2019. 43-year-old Jean-Pierre Labelle from Ashey Road in Ryde was initially arrested by NCA officers in March, but he was re-

arrested on Saturday 27 June and charged for importing class A drugs the next day.

Port worker jailed after being caught with cocaine and cash

A port worker who was caught in possession of cocaine as he left work has been jailed for nearly seven years following a National Crime Agency investigation. Ben Whitby, 30, from Grimsby was pulled over by officers from Humberside Police, who were working with the NCA, as he drove away from



cash.

Killingholme Port in north Lincolnshire on 18 February. On the back seat of his BMW car officers found a black rucksack containing around 2.25 kilos of cocaine, with an estimated potential street value of £178,000. In the glove box they found £3,000

Six arrested and luxury cars seized as part of drugs and money laundering



Suspected members of an organised crime group in Merseyside have been arrested as part of a drug trafficking conspiracy. Five men aged between 35 and 48, and a woman aged 35, were arrested in raids in the Wirral and Wallasey, and Deeside, by officers from the National Crime Agency, with support from Merseyside Police. All five men were apprehended on suspicion of conspiracy to import controlled drugs, conspiracy to launder money, and participating in the

activities of an organised crime group. The woman was arrested on suspicion of conspiracy to import controlled drugs and money laundering. All remain in custody for questioning and the 48-year-old man has been recalled to prison.

Bermondsey shop owner intended to sell illegal knives for profit

A man who attempted to smuggle an array of illegal weapons into the UK has been jailed for 21 months. 53-year-old Kamber Ramadani from Bermondsey in east London told National Crime Agency investigators that he planned to sell the flick knives, butterfly knives and other weapons in his shop



on the Old Kent Road. He had been stopped by Border Force officers carrying out checks on incoming traffic at Dover docks on 12 February 2019, initially telling them he'd been out of the country visiting Croatia and Kosovo.

During a search of his Mercedes officers found 28 different bladed weapons in the boot, and a starter pistol

and ammunition in the footwell.

Cash courier jailed for smuggling £12 million out of the UK

A Turkish lorry driver has been jailed today for smuggling over £12 million of criminal cash out of the country over a five-month period. Nasuf Nasufoglu, 40, from Istanbul, was targeted as part of an investigation by the joint National Crime Agency and Metropolitan Police Organised Crime Partnership. Nasufoglu was arrested on 27 September 2019 at the Port of Dover, where UK Border Force officers found six packages of cash hidden in fridge panels in his lorry totalling £264,050. He was also in possession of £1,200 and 900 euros - his payment for acting as a courier - plus eight mobile phones and multiple SIM cards.

Phone evidence showed OCP officers that Nasufoglu couriered money approximately 45 times between 1 May 2019 and the day he was arrested. Images on his phone depicted 272 unique packages, which officers estimated held £12 million in cash.

Five arrested and 30k seized linked to people smuggling

Five men have been arrested and around £30,000 cash seized as part of a National Crime Agency investigation into the smuggling of migrants into the UK.

The five, a 29-year-old Albanian and four Afghan nationals all aged between 39 and 43, were detained by NCA officers on suspicion of facilitating illegal immigration in the Notting Hill area of West London. Two Afghan women aged 65 and 26, who investigators suspect had recently arrived in the UK in the back of a lorry, were also detained and were later handed to Immigration Enforcement.



Three arrested as NCA makes record drug seizure in Northern Ireland



Three men have been arrested following the biggest drug seizure ever made in Northern Ireland by the National Crime Agency. As part of an ongoing NCA investigation into drug supply, NCA officers, in a joint operation with colleagues from the Police Service of Northern Ireland, moved in to stop a lorry in the Templepatrick area in the early hours of Wednesday 3 June.

NCA and PSNI officers recovered an estimated 600 kilos of herbal cannabis from among a cover load of vegetables.

Four UK neo-Nazis jailed for membership of National Action

Four neo-Nazi “diehards” convicted of being members of the banned terrorist group National Action have been jailed. Alice Cutter, a former Miss Hitler beauty pageant contestant, and her former partner Mark Jones were convicted of membership of a terrorist group after a trial in March, alongside co-accused Garry Jack, and Connor Scothern.

Prime Ministers car shunted by security vehicle



The car that usually carries British Prime Minister Boris Johnson was shunted by a security vehicle outside parliament when Kurdish protesters ran into the road. The vehicle was leaving the parliamentary estate with police outriders when a protester ran into the road, prompting the official car to stop and the following Range Rover to drive into it. Both cars moved off in a matter of seconds.

Unlicensed Cwmbran security boss must pay court order

A former security boss has been ordered to pay more than five thousand pounds from the proceeds of his crimes or face a prison sentence. Nicholas Seabrook, of Cwmbran, was handed a Proceeds of Crime 2002 (POCA) confiscation order of £5,560.59 at Cardiff Crown Court last Friday, 29 May 2020.

Seabrook’s sentence follows his guilty plea last December for working as an unlicensed security director, and for failing to provide information to the Security Industry Authority (SIA) at Cwmbran Magistrates’ Court. Seabrook must pay the full amount by 31 August 2020 or face a three-month jail

sentence. He was also fined £500, which must be paid before 30 June 2020. He is also required to pay court costs of £250 and a victim surcharge of £38.

Security guard at the London NHS Nightingale Hospital saves a woman from drowning

A quick-thinking London door supervisor saved a woman from drowning whilst working as a security guard at the NHS Nightingale Hospital in east London.

Elizabeth George, of Streatham, is a Security Industry Authority (SIA) licensed door supervisor, who is being featured in the SIA's #SIAHeroes campaign. The campaign highlights the efforts security operatives are making to serve their communities across the UK during the COVID-19 crisis. On the morning of 15 May, Elizabeth was on patrol alongside the river and saw a woman who appeared to be distressed standing on the connecting footbridge over the Thames. The woman was too far away to engage with, but Elizabeth saw her throw a bag into the fast-flowing river before she then jumped in after it. Elizabeth quickly raised the alarm both internally and with the marine police unit, who swiftly responded and saved the woman's life by pulling her out of the river.

City Security Council and City of London Police work on joint patrolling strategy



The all 22 member security companies involved with the City Security Council recently took part in a joint high visibility patrolling strategy with the City of London Police as part of an initiative designed to deter potential building attacks from protest group Extinction Rebellion. The joint initiative, which was implemented over the May Bank Holiday weekend, witnessed combined patrols being set up

across the City Security Council sites within the Square Mile of London. Approximately 1,000 security officers took part in the exercise and were ably supported by the police who were out in force both on foot and as mounted police officers.

City Nominations for 2020 Sheriff's Award requested by the Worshipful Company of Security Professionals



The City of London Sheriffs' Award is an inspiration-centric award presented annually to an individual who has acted in a brave manner in order to confront danger to another person or their property and also to celebrate such selflessness. The Sheriffs' Award for Bravery is now in its twelfth year, with The Worshipful Company of Security Professionals calling for nominations.

The Sheriffs' Award is a national award for bravery specifically designed to celebrate people who have contributed towards safeguarding our "people, property or liberty". The award was instituted back in 2006 by The Worshipful Company of Security Professionals in the wake of the 7/7 London tube and bus bombings that occurred the previous year and, since then, has been awarded on an annual basis by the Sheriffs of the City of London.

Armed Forces announce launch of 'Cyber Regiment'



A new 'Cyber Regiment' has been launched to protect front line operations from digital attack as the defence sector continues its modernisation to combat the threats of tomorrow, The Ministry of Defence has launched the 13th Signal Regiment, a dedicated Cyber Regiment which will protect vital defence networks at home and on operations overseas. The unit was formally stood up on Monday 1 June at a ceremony held at Blandford, home of the Royal Signals.

Europol launches European Financial and Economic Crime Centre

EUROPOL has launched the European Financial and Economic Crime Centre. This will enhance the operational support provided to EU Member States and EU bodies in the fields of financial and economic crime and continually promote the systematic use of financial investigations. The European Financial and Economic Crime Centre has been established within the current organisational structure

of Europol that is already playing an important part in the European response to financial and economic crime and will be staffed by 65 international experts and analysts. Read the full article here:

Government unveils new police powers designed to tackle hostile state activity

Police Officers operating at UK ports will be able to stop, question, search and detain individuals to determine whether they are a spy as part of a range of measures being put before Parliament by the Conservative Government. The new

Schedule 3 powers were introduced as part of the Counterterrorism and Border Security Act 2019 in response to the poisoning of five people in Salisbury using a military-grade nerve agent. Tragically, Dawn Sturgess (one of the victims of the attack) later died

Security professionals warn UK government over outdated cybercrime legislation

The UK's Computer Misuse Act came into effect 30 years ago, but security professionals are warning that it is no longer fit for purpose and may even be hindering their efforts. A coalition of businesses, trade bodies, lawyers and think tanks from across the cybersecurity industry have today taken the unprecedented step of uniting to write a letter to the prime minister urging him to reform the law.

The coalition includes large cyber security consultancies like NCC Group and F-secure, industry trade body techUK, cybersecurity software developers McAfee and Trend Micro, international accreditation body CREST, the think tank Demos, and a number of prominent lawyers in the field.

Demonstrations held / planned

Thousands protest in London over US Police Violence

Thousands of people gathered in Hyde Park, central London, on the 3rd June to denounce the killing of an unarmed black man in the US. The protest, organised by campaign group Black Lives Matter, marched through London to Westminster via Victoria station, causing localised transport disruption. Some minor scuffles were reported, with police detaining at least 13 individuals. Further protests against police violence in the US are expected in London on 6 June.

Health Secretary urges people not to participate in protests

The health secretary called for people not to participate in protests denouncing police violence, citing concerns over the potential spread of coronavirus (COVID-19). Protests are planned across the UK on 6 June to denounce racism and police violence after US police killed an unarmed black man, George Floyd, in Minneapolis on 25 May. The incident triggered major nationwide protests in the US, along with protests and memorial events in the UK on 30 May and 3 June.

Thousand protest nationwide to denounce police violence

Thousands of people protested in London and other cities across the UK to denounce police violence. Protesters gathered in response to the US police killing of an unarmed black man in Minneapolis in



May. Most of the protests were peaceful. However, as demonstrators dispersed in London, a small number of protesters near Downing Street threw bottles at police, and mounted officers charged at protesters to push them back. Police arrested 14 people and 10 officers were injured during the protest. More than 1,000

protesters also marched past the US Embassy in Battersea, disrupting traffic.

Protesters gather nationwide against police violence



Tens of thousands of people protested in London and other UK cities to denounce racially motivated police violence and to support the Black Lives Matter movement. Protesters in London gathered outside the US embassy in Battersea

before marching to Westminster. Sporadic clashes with police resulted in 12 arrests and eight officers receiving injuries in the capital. In Bristol, a large crowd tore down a statue and protesters in Birmingham caused the closure of the M6 motorway during the afternoon. Protests were reported in several other cities nationwide including Cardiff, Edinburgh, Glasgow, and Manchester.

Police clash with protesters in London

Police clashed with far-right protesters outside Waterloo Station in London, with reports of protesters throwing missiles and fireworks. Police arrested more than 100 people following the clashes that broke out after police attempted to separate the protesters from anti-racism groups in rival demonstrations. Far-right activists took to the streets vowing to protect historic monuments that have been targeted by some anti-racism protesters.

Far-right protesters clash with police in Glasgow



An unspecified number of far-right protesters from the National Defence League clashed with police officers in George Square, Glasgow, prompting police to arrest six people. The group gathered in Glasgow claiming they wanted to protect historical landmarks in the city. After the right-wing protest dispersed, hundreds of rival activists marched peacefully defending the rights of immigrants in the city. Similar far-right protests occurred in London on 13 June, where clashes with police also broke out.

Arrests after selling fake Coronavirus testing kits



A Birmingham man has been arrested for allegedly selling fake coronavirus testing kits on the dark and open webs, as part of the National Crime Agency's response against criminals trying to exploit the Covid-19 pandemic. The 38-year-old, who was arrested at his home in the city's Jewellery Quarter, was taken into custody yesterday for alleged offences under the Fraud Act 2006. He is believed to

have sold the kits to customers in the UK and United States.

A second man who was wanted by the National Crime Agency for allegedly selling fake coronavirus kits on the dark and open web has been arrested in London.

Police Service continues to witness crime levels falling during lockdown

Provisional data from police forces in England and Wales shows continued falls in recorded crime compared to last year, with the lockdown effect on crime still holding. Provisional snapshot figures show that police recorded crime from the 43 police forces in England and Wales has fallen overall by 18% – excluding fraud, which is recorded centrally by Action Fraud – in the four weeks to 7 June when compared to the same period in 2019.

Male security guards have the highest rate of COVID-19 deaths in the UK

Male security guards have the highest rate of coronavirus deaths in the UK, according to new figures. Data released by the Office for National Statistics (ONS) showed people working in social care, the NHS and in occupations such as cleaning, construction work and security, are more likely to die with COVID-19. The report follows the announcement in May by the Office of National Statistics (ONS) that the death rate among security officers is 45.7 deaths per 100,000 people, one of the highest in the UK.
